
child is not charging lunches. When a family's balance of -\$25.00 (negative twenty-five dollars) is incurred, the student will be served an alternate reimbursable meal.

Advisory To Parents/Guardians

Dear Parent or Guardian:

State of Michigan law requires schools and day care centers that may apply pesticides on school or day care property to provide an annual advisory to parents or guardians of students attending the facility.

Please be advised that the Forest Park School District utilizes an Integrated Pest Management (IPM) approach to control pests. IPM is a pest management system that utilizes all suitable techniques in a total pest management system with the intent of preventing pests from reaching unacceptable levels or to reduce an existing population to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion, and biological controls. One of the objectives of using an IPM approach is to reduce or eliminate the need for chemical applications of pesticides. However, certain situations may require the need for pesticides to be utilized.

As required by State of Michigan law, you will receive advance notice regarding the non-emergency application of a pesticide such as an insecticide, fungicide or herbicide, other than a bait or gel formulation, that is made to the school or day care grounds or buildings during this school year. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be notified following any such application.

Advance notification of pesticide applications, <u>other than a bait or gel formulation</u>, will be given by at least two methods. The first method will be by posting at the main entrance to the school, which is located at 801 Forest Parkway, Crystal Falls, Michigan. The second method will be by:

Posting on the school web site.

Please be advised that parents or guardians of children attending the school are entitled to receive the advance notice of a pesticide application, <u>other than a bait or gel formulation</u>, by first class United States mail postmarked at least 3 days before the pesticide application, if they so request. If you prefer to receive the notification by first class mail, please complete the attached form and return it to our office.

Please be advised that parents or guardians of children attending the school may review the school's Integrated Pest Management program and records of any pesticide application upon request. Forest Park typically only uses pesticide treatment on the practice field and football field during the summer to eliminate weeds.

A truancy initiative

Michigan Law states in pertinent part (MCL 380.1561):

"...every parent, guardian, or other person in this state having control and charge of a child from the age of 6 to the child's sixteenth birthday shall send that child to a public school during the entire school year. The child's attendance shall be continuous and consecutive..."

THE ABC'S OF PROJECT BACK TO SCHOOL:

- When a truancy pattern develops such as unexcused absences, excessive tardiness, and/or illnesses, the school will contact the juvenile truancy diversion officer.
- The juvenile truancy officer will discuss the circumstances with the school official, obtain copies of the child's records, if appropriate, and arrange a meeting with the child's parent/guardian.

- At the meeting between the juvenile truancy officer and the parent/guardian the following steps would be taken:
 - -- The cause of the absences will be determined;
 - --Information on prevention services and the implications of formal court action will be discussed;
 - -The parent/guardian and truancy officer will agree on an informal "truancy plan" designed to curb any further truancy issues.
 - --The plan will be submitted to the school for approval and The school, parent, and truancy officer will sign the plan. --The truancy officer will monitor compliance with the plan.
- If sufficient progress is not made the school will send a letter to the the parent/guardian either via registered mail or by personal service.
- If the issue is still not resolved, the school will complete the referral form, execute the affidavit, and gather the documentation listed on the checklist and turn those items over to the appropriate police agency for an investigation.

Michigan Truancy Laws

Juvenile Truancy Laws - MCL 712A.2(a)(4):

(4) The juvenile willfully and repeatedly absents himself or herself from school or other learning program intended to meet the juvenile's educational needs, or repeatedly violates rules and regulations of the school or other learning program, and the court finds on the record that the juvenile, the juvenile's parent, guardian, or custodian, and school officials or learning program personnel have met on the juvenile's educational problems and educational counseling and alternative agency help have been sought. As used in this sub-subdivision only, "learning program" means an organized educational program that is appropriate, given the age, intelligence, ability, and psychological limitations of a juvenile, in the subject areas of reading, spelling, mathematics, science, history, civics, writing, and English grammar.

Mich. Comp. Laws Ann. § 380.1561 - Compulsory School Attendance

Sec. 1561. (1) Except as otherwise provided in this section, for a child who turned age 11 before December 1, 2009 or who entered grade 6 before 2009, the child's parent, guardian, or other person in this state having control and charge of the child shall send that child to a public school during the entire school year from the age of 6 to the child's sixteenth birthday. Except as otherwise provided in this section, for a child who turns age 11 on or after December 1, 2009 or a child who was age 11 before that date and enters grade 6 in 2009 or later, the child's parent, guardian, or other person in this state having control and charge of the child shall send the child to a public school during the entire school year from the age of 6 to the child's eighteenth birthday. The child's attendance shall be continuous and consecutive for the school year fixed by the school district in which the child is enrolled. In a school district that maintains school during the entire calendar year and in which the school year is divided into quarters, a child is not required to attend the public school more than 3 quarters in 1 calendar year, but a child shall not be absent for 2 or more consecutive quarters.

- (2) A child becoming 6 years of age before December 1 shall be enrolled on the first school day of the school year in which the child's sixth birthday occurs, and a child becoming 6 years of age on or after December 1 shall be enrolled on the first school day of the school year following the school year in which the child's sixth birthday occurs.
- (3) A child is not required to attend a public school in any of the following cases:
- (a) The child is attending regularly and is being taught in a state approved nonpublic school, which teaches subjects comparable to those taught in the public schools to children of corresponding age and grade, as determined by the course of study for the public schools of the district within which the nonpublic school is located.
- (b) The child is less than 9 years of age and does not reside within 2-1/2 miles by the nearest traveled road of a public school. If transportation is furnished for pupils in the school district of the child's residence, this subdivision does not apply.

- (c) The child is age 12 or 13 and is in attendance at confirmation classes conducted for a period of 5 months or less.
- (d) The child is regularly enrolled in a public school while in attendance at religious instruction classes for not more than 2 class hours per week, off public school property during public school hours, upon written request of the parent, guardian, or person in loco parentis under rules promulgated by the state board.
- (e) The child has graduated from high school or has fulfilled all requirements for high school graduation.
- (f) The child is being educated at the child's home by his or her parent or legal guardian in an organized educational program in the subject areas of reading, spelling, mathematics, science, history, civics, literature, writing, and English grammar:
- (4) For a child being educated at the child's home by his or her parent or legal guardian, exemption from the requirement to attend public school may exist under either subsection (3)(a) or (3)(f), or both.
- (5) For a child who turns age 11 on or after December 1, 2009 or who was age 11 before that date and enters grade 6 in 2009 or later, this section does not apply to the child if the child is at least age 16 and the child's parent or legal guardian has provided to school officials of the school district in which the child resides a written notice that the child has the permission of the parent or legal guardian to stop attending school.

380.1599. Offenses and penalties

A parent or other person in parental relation who fails to comply with this part is guilty of a misdemeanor, punishable by a fine of not less than \$5.00 nor more than \$50.00, or imprisonment for not less than 2 nor more than 90 days.
